Eligibility determiner for Australian Government Non-APS employees

- Must join no choice available.
- Must be offered 'Choice' but eligible to elect to join this scheme. Stapling rules may apply
- × Not eligible to join scheme.
- New AGS number required.
- Same AGS number used if ongoing, or if they elect to join PSS.
- Employee eligible if they have not defaulted and they meet the following PSS eligibility criteria:
 - employed on a contract for three months

or

• had three months Australian Govt employment in the last two years

or

- have the intention to pay a transfer value into PSS.
- Scheme not eligible as default fund. If employee does not join available schemes and does not have a stapled fund, the employer must select a fund other than CSS, PSS or PSSap.

Non-Contributing member means a person with a CSS or PSS preserved/deferred benefit or a CSS invalidity pension. If your emplyee has a PSS invalidity pension, please contact CSC for specific guidance.
