Who should use this form?

Use this form if you are receiving DFRDB retirement or invalidity pay and require a recalculation of your tax-free amount to include your pre 1 July 1983 excess contributions.

When to use this form?

Use this form if you have not previously advised the DFRDB of your pre 83 excess contributions. If you have previously advised DFRDB of your pre 83 excess contributions, this amount has already been converted to a tax-free amount.

Definitions

Pre 83 excess contributions: Contributions made to DFRDB prior to 1 July 1983 which, together with life insurance premiums (if any), exceeded an annual limit of \$1,200. Records of these contributions are held by the Australian Taxation Office (ATO).

Tax-free amount: The tax-free amount is based on your member contributions made after July 1983, together with any pre 83 excess contributions that you applied to your retirement pay. Please note you are not eligible for an increase in your tax-free amount if you previously elected to receive your pre 83 excess contributions as part of a lump sum.

Documentation from the Australian Taxation Office

As records of your pre 83 excess contributions are held by the ATO, you will need to:

If you are receiving a reversionary pension please obtain a letter directly from the ATO confirming the value of your late spouse's pre-July 1983 excess contributions.
